

## PRE-QUALIFICATION CRITERIA – TENDER- S1

The Tender Scrutiny Committee as a whole will evaluate the Pre- Qualification Proposals/ Forms on the basis of their Audit Financial Statements, Experience, Project Executed, Project Experience, Qualification and Experience of key personnel, applying the evaluation criteria specified in Tender Document.

### SCHEDULE-1

**Title: Design, Detailed Engineering and Civil Construction of Tanks and Buildings and all allied works for the Salt Processing Unit.**

#### *Eligibility Conditions for Bidders:*

1. Bidders should have a Permanent Account Number (PAN).
2. GST Registration (GSTIN) valid on date of Bid submission.
3. The company should be a registered company (under Indian Companies Act) operating in INDIA for a minimum period of 5 years.
4. The bidder should have an average annual turnover of **₹370.74 lakh** (100% of the estimated tender value) during the last three consecutive financial years ending on 31st March 2025.
5. The bidder should submit a solvency certificate of **₹148.29 lakh** (40% of the estimated tender value), issued by a Scheduled Bank.
6. The bidder should not have been blacklisted or debarred by any Government department or agency as on the date of bid submission.
7. The bidder should have successfully executed any one of the following during the last **5 years**:
  - a. Three similar works each costing not less than **₹ 148.29 lakh**, or
  - b. Two similar works each costing not less than **₹ 222.44 lakh**, or
  - c. One similar work costing not less than **₹ 296.59 lakh**.
8. The bidder should have completed at least one civil work of similar nature (construction of tanks/buildings in Water or Waste Water Treatment Plants) within the last 3 years.

Work Order and completion certificate shall be attached along with tender document.

## SCHEDULE-2

**Title: Design, Detailed Engineering and Civil Construction of Central Monitoring Building, VSA Building, Blower house including electrical, piping and all allied works.**

### ***Eligibility Conditions for Bidders:***

1. Bidders should have a Permanent Account Number (PAN).
2. GST Registration (GSTIN) valid on date of Bid submission.
3. The company should be a registered company (under Indian Companies Act) operating in INDIA for a minimum period of 5 years.
4. Average Annual Turnover of **Rs. 208.77 Lakh** (100 % of estimated tender value) for the last three consecutive years as on 31st March 2025.
5. Solvency Certificate of **Rs. 83.51 Lakh** (40 % of estimated tender value) from scheduled banks.
6. Tenderer should not have been black listed/debarred by any Government organization.
7. The bidder should have executed three works each of **Rs. 83.51 Lakh** (40% of value) or Two works, each of **Rs. 125.26 Lakh** (60% of value) or One work of minimum of **Rs. 167.01 Lakh** (80% value) in the last 5 years.
8. The bidder should have completed at least one civil work of similar nature in Water/Waste Water Treatment plants within the last 3 years.
